- Six Points of Celebrations in Wooster:
 - 1. <u>Economically Disadvantaged Academic Gap Closure</u> 49% of the students in the Wooster City School District (WCSD) are economically disadvantaged. District analytics in 2008 detailed that this student sub-group was underperforming academically (between 10 30% on most academic achievement indicators). The WCSD leadership teams (DLT/BLT/TBT) made closing this achievement gap a strategic priority. Through terrific strategic planning, the WCSD has closed the achievement gap for our economically disadvantaged students and significantly increased more equitable access to rigorous academic pathways and career planning/placement.
 - 2. <u>Creating a Culture for School Improvement and Strategic Planning</u> The school system investigated several researched-based school improvement models and, in 2008, chose the Ohio Improvement Process (OIP). The school system has worked tirelessly to implement, with great fidelity and integrity, this distributive leadership model. The OIP protocols have significantly improved our literacy for data-based decision-making, adult processes for progress monitoring of goals and action steps and our overall growth mindset for continuous improvement.
 - 3. <u>Creating a Culture of Literacy</u> 24% of annual incoming kindergarten students enter the school year 3-15 months behind the expected standard for reading. In 2013, a Literacy Committee was established to improve the overall culture for literacy in the WCSD. In 2016, each elementary school and middle school received a literacy coach to build capacity for improved instructional leadership; assessment literacy; delivery

- of job-embedded, research-based professional development; a commitment to highly effective teaching/teachers; and strategic, accelerated interventions. The results have been fabulous. Employee morale is high and student achievement improving.
- 4. <u>Fiscal Responsibility</u> Since 1977 the WCSD was on the ballot every 3-4 years requesting increased revenue for operations from the electorate. Through the assistance of the Business Advisory Council (BAC), expenses were evaluated. After the passage of a successful operating levy in 2010 the district reorganized with the goal to stay off the ballot for a period of six to eight years. After 14 months of stakeholder engagement, the community agreed to close two elementary schools and move grade 8 into the high school. This strategy saved approximately \$1.4 million annually. Current financial analytics forecast a levy in 2020, meaning the strategy extended the 2010 operating levy to 10 years!
- 5. Successful Levy Passage In May, 2017 we offered the electorate a 1.5 mill permanent improvement levy that would raise \$1.2 million annually. The campaign was structured to explain the need for the funds and how the dollars supported the school systems strategic priorities. The campaign deliverables were graphic, comprehensive, social and scaffold. The community supported the request by a 75/25 margin, the largest support for new money in the history of the school district.
- 6. <u>Implementation of Blended Curriculum</u> In 2014 the Wooster CSD began researching blended learning platforms and personalized learning systems. Nearly 40% of the curriculum is now delivered in a hybrid, digital environment. This has led to more efficient annual curricular updates; accelerated, rigorous and personalized instructional pacing, just in-time interventions and differentiation; and more graphically appealing delivery for our millennial and beyond generations. What has not changed and will never change is that this philosophy is grounded and centered with the expertise of the amazing faculty and support staff of the Wooster CSD. The technology is amazingly and wonderfully innovative. Our professional, kind and compassionate human resources though is the true lever for learning.
